Update Message

Hopefully everyone had a relaxing long weekend, and managed to enjoy the good weather while maintaining physical distancing.

We have had a little more service delivery work on our plate recently – a lot of this is in support of HMCS OTTAWA. One of our ‘critical tasks’ is to ensure the minimum requirements are met to allow her transfer to, and docking by, Victoria Shipyards at the end of the month. However, we won’t take on any more than the bare minimum work to achieve this requirement, and we are so far managing to keep on-site personnel down to, at most, six percent of the work force.

Also, the **FMFTM 02-20 Op LASER FMF CB Personnel Safety Procedure (COVID-19)** has been released. This gives direction on how to safely work on-site, either in the FMF or on ships. If you are called in to work, please ensure that you read and follow this FMFTM.
